Submit the original and two copies of the completed papers to the family law division. The clerk will file the completed papers and return two copies of the forms to you. One set of the paperwork is yours to keep for your records. Please bring it with you to all court appearances and when you seek legal assistance from any source.

The other set of papers needs to be personally served on the other party, along with the blank Responsive Declaration, FL-320 and blank Proof of Service by Mail FL-335, at least 21 days before the scheduled hearing. You may not serve the papers yourself. Anyone other than yourself and over the age of 18 may serve the papers, or you may ask the sheriff's department to serve the papers for you (for a fee). If a party other than the sheriff serves the papers, the person serving the papers must complete and sign the Proof of Personal Service. The Proof of Personal Service FL-330 must then be filed with the family law clerk.

Personal service is the preferred method for serving the other party. There are certain instances, however, when the motion forms can be served by mail. If you have questions about whether or not your papers can be served by mail, please ask the family law clerk, or seek legal assistance.
