In response to the spread of COVID-19, a state of emergency was declared in the State of California on March 4, 2020, which was followed on March 13, 2020, by a national declaration of a state of emergency. Beginning on March 16, 2020, California counties began issuing shelter-in-place or stay-at-home orders. On March 19, 2020, California Governor Newsom required all Californians to stay home, subject to certain limited exemptions. Courts are included in this exemption.

Chief Justice Tani G. Cantil-Sakauye, Chair of the Judicial Council of California, issued an order on March 23, 2020 requiring superior courts to suspend jury trials for 60 days, unless they were able conduct such a trial at an earlier date, upon a finding of good cause shown or through the use of remote technology; extending statutory deadlines for holding last day trials in criminal and civil proceedings; and authorizing courts to adopt any proposed local rules or rule amendment intended to address the impact of the COVID-19 pandemic to take effect immediately, without advance circulation for public comment. As authorized by Chief Justice Cantil-Sakauye, the Sonoma County Superior Court declared March 30, 2020 through April 14, 2020 as judicial holidays. Finally, the court is not open to the general public until June 1, 2020 and is only providing essential services per the court's First Amended Omnibus General Order of the Presiding Judge re: Court Operations issued on April 28, 2020.

In light of the foregoing, the court finds good cause to continue currently set civil trials, and select civil matters, in order to ensure the orderly administration of justice. Pursuant to the court's authority under Code of Civil Procedure section 128, the matters listed below and presently or previously scheduled in Department 19 of the court are continued as follows:

ALL MATTERS SET TO BE HEARD THROUGH MAY 29, 2020, SHALL BE HEARD REMOTELY VIA "ZOOM" ONLY; NO PARTY OR REPRESENTATIVE OF A PARTY MAY APPEAR PERSONALLY IN THE COURTHOUSE.
