This is in response to the 2003-2004 Sonoma Grand Jury Report on the Adobe Creek Debacle and Restoration. Below are the required responses to recommendations from the Petaluma City School District, Board of Education, and Principal of Casa Grande High School:

**R2.** Ron Everett, Principal, Casa Grande High School, has attended meetings and been apprised of the curriculum development that will be incorporated into courses on campus for the 2004/05 school year. Casa Grande High School will implement the pilot program and based on successful implementation the course outlines and antidotal support will be provided to Petaluma High School for future use.

**R5.** The District is paying for Casa Grande High School certificated staff to meet with representatives of the agencies to Develop the pilot program. Casa Grande is involved in the development of curriculum and with successful implementation it will be made available to Petaluma High.


**R7.** Ron Everett, Principal, Casa Grande High School, will establish a monthly meeting to review minutes from the UAC Board of Director's meeting. Areas of needed support and oversight will be a standing topics for discussion. Identification of an additional backup position will be explored.
