<u>**RESPONSE</u>: The recommendation has been implemented.</u></u>** 

The Sonoma County Department of Emergency Services has an active mapping program to maintain current information of streets, roads, addresses and landmark locations. Department staff frequently receives road naming and address changes from the Sonoma County Permit and Resource Management Department. This information is reviewed and sent to Sonoma County GIS for mapping updates.

The Sonoma County Department of Emergency Services is also an active participant of the REDCOM Joint Powers Authority and the Department's response area is included in the GIS mapping database. The Department is GIS mapped and routinely updated in the REDCOM CAD computer via Sonoma County GIS.

The Department is working on providing map books for all staff and volunteer apparatus. Department staff will continue to work with the County of Sonoma GIS and REDCOM towards efforts to create a map book printed from GIS based information. A GIS based map book would contain accurate information about parcel, address, and landmark locations and can be easily updated and distributed.

We receive notices from the County of Sonoma Permit and Resource Management Department advising us of a new or changed address in the district. Also, fire personnel periodically and systematically check addresses in the district on drill nights or as an assigned project and submit map book correction

forms for discrepancies.

Corrective information is transferred into the main run book and all other map books are updated. In addition to all of these measures, Bennett Valley Fire District utilizes a computerized mapping program.

Please accept the following letter as the response by the District to the Recommendations made by the Sonoma County Grand Jury in its 2002-2003 Final Report. This response is submitted in accordance with Penal Code §§ 933 and 933.05. For ease of reference, I reproduced each Recommendation to which a response was required, followed immediately by the District's response.

#### Recommendation Number 1:

The Bodega Bay Board of Directors is urged to meet with its legal counsel to discuss the Brown Act, especially as it applies to meetings, closed sessions and agendas for all meetings.





#### **RECOMMENDATION:**

R2. Fire district boards should enforce continual up-dating and correction of their maps.

#### **RESPONSE:**

The recommendation has been implemented. The following is this district's summary:

The Geyserville Fire Protection District (GFPD) spans an area more than 200 square miles from The Geysers to Las Lomas, and from Healdsburg to Cloverdale, making it the largest fire district Sonoma County. This area includes some of the most remote portions of the County and the GFPD is very aware of the importance to maintain accurate maps.

In 1998 the GFPD completed a comprehensive mapping project that incorporated all earlier versions of map books and addresses into one map using AutoCAD software. The AutoCAD map was divided into smaller maps and used for a "box" style dispatch system with the then Central Dispatch. As new addresses were made, the map was updated. The maps were even used by the Sonoma County Sheriff's Department to locate addresses, while they provided very little input or funding for the process.

As technical support and expertise with the AutoCAD software diminished, the maps became outdated. In 2000 the GFPD pro-actively embarked on a similar project using more appropriate geographic information system (GIS) software. The GFPD began working with Sonoma County Information Systems Department (ISD) to share data and then to create maps for REDCOM dispatching. This has been done using GIS software and the Geographic Positioning Systems (GPS). This mapping process is currently not completed. Since these maps will also be placed into a countywide database, they will be used by agencies that have not provided any funding. At this point the GFPD wonders if it is the District's *legal obligation* to maintain these maps?

The GFPD strives to maintain accurate maps through updates sent out by the County, field verification, and through discovering errors during emergencies. There are several

reasons, why "perfect" maps will never exist. Among them are the following:

- There exist too many streets with aliases. For example, Highway 128 in Geyserville is also called Depot Street. Likewise, Geyserville Avenue is also referred to as Old Redwood Highway.
- Sonoma County is engaged in a never-ending process of renaming streets that have more than three residences.
- Addresses seem affected by power and/or residences' phone companies as new accounts are created that don't coincide with the County permit process.
- At some time in the past the Sonoma County Sheriff's Department assigned names to private roads. In some cases the change was unknown to the residences of that road.
- *Thomas Brothers Maps* success at producing maps has also created incorrect names to streets.

The GFPD has been updating and correcting its maps for the safety of all its residents in the District. As a Board the District is curious as to the question above; who is legally responsible for maintaining the maps?





<u>RESPONSE</u>: The recommendation has been implemented.

The Rancho Adobe Fire Protection District has an active mapping program to maintain current information of District streets, roads, addresses and landmark locations. District staff frequently receives road naming and address changes from the Sonoma County Permit Management & Resource Dept. and updates the master District map book, carried in all District fire engines and command vehicles.

The Rancho Adobe Fire District is also an active participant of the Redcom Joint Powers Authority and the District's response area is included in the GIS mapping database. The District is GIS mapped and routinely updated in the Redcom CAD computer via Sonoma County GIS.

In December of 2002, the District purchased an "ARC Pad" program that allows specific locations to be GIS mapped and added to the master GIS database. The program allows much more precise mapping of addresses, landmarks and geographic locations above what the Sonoma County GIS program provides.

The current District map book is an evolution of hand-drawn maps that are also updated by hand. District staff will continue to work with the County of Sonoma GIS and Redcom towards efforts to create a map book printed from GIS based information. A GIS based map book would contain accurate information about parcel, address, landmark locations and can be easily updated and distributed. The District will continue its proactive program of mapping and updating its emergency response area.

#### **Recommendation R3 - Page 37**

The Sonoma County Board of Supervisors and the Rancho Adobe Board should meet with Sonoma State University representatives to negotiate an agreement to compensate the District for its services.

<u>RESPONSE</u>: The recommendation has been implemented to the extent legally permissible.

The Rancho Adobe Fire Protection District has been actively involved in discussions with the Sonoma State University administration since the construction of the University, but more specifically over the past year regarding emergency response, special events, new construction projects and Fire District finances.


While the staff of the Sonoma State University is sympathetic and supportive of efforts to generate revenue, the Sonoma State University property is considered state property and is legally exempt from local ordinances and special taxes. University staff is concerned about the campus' impact on District operations.

On going meetings have taken place between District and Sonoma State staffs to explore areas of partnership and potential revenue sources that would benefit the District and support fire protection services to the University.

The University has recently assisted District staff with the preparation of a grant request (\$200,000+) for upgrading firefighter breathing apparatus.

District staff is optimistic that there will be opportunities to collaborate with University staff to obtain necessary equipment and resources that will enhance service both to the University and the entire District.

This response was approved by the Board of Directors of the Rancho Adobe Fire Protection District at their regular meeting of August 20, 2003.



Districts," and specifically the language that states "Fire district boards should enforce continual updating and correction of their maps," we respond with the following information.



Dear Foreperson Simpson:

As per your letter dated July 3, 2003, the Russian River Fire Protection District is responding to your requirement that our agency respond within sixty (60) days as to the findings from your referenced Grand Jury Report. Although our agency was not specifically named within this report, we were included under the section of "Special Fire Protection Districts" on page 35 of that report; and more specifically under "Recommendations; R2. Fire district boards should enforce continual up-dating and correction of their maps."

The Russian River Fire Protection District (RRFPD) has been fully cooperating with the County and the new dispatch center (REDCOM) to continually update our District maps; especially when deficiencies arise from responding to emergencies. However, our county maps are apparently being held by LAFCO and it may be that any needed changes must also be submitted through their process in order to be consistent. No matter what, you can be assured we will continue to do our best with keeping our maps up-to-date. Our inhouse run books are updated annually, or as often as new street notices are received from the County.

The Russian River Fire Protection District would also like to respond to "Findings, F7" on page 36 of the Final Report. This section deals with the "merger of fire districts and use of joint powers agreements". The findings did not share the fact that the Russian River Fire Protection District (formerly; Guerneville Fire P.D.) consolidated with Oddfellows Recreation Park Fire Brigade and the Rio Nido Fire Protection District that currently operates out of one main fire station located in Guerneville. As well, RRFPD has been meeting with our neighboring districts (Forestville, Monte Rio, Bodega Bay Fire Departments) over the last several years in an attempt to consolidate with each of them. So far, our attempts have not been successful. However, recently the Monte Rio Fire Protection District has been receptive to the idea and is willing to go before the voters of their district (in March 2004) to try and pass a Special Tax Measure much like the one

already in place at RRFPD. This would go a long way toward helping these two districts consolidate. Additionally, we currently share a Fire Chief.

As for the use of Joint Powers Agreements, Zone 5 Districts have been operating under such agreements over the past several years with Training Drills (Ya-ka-ama, MADD exercises, etc.) We have also signed agreements with the Cities of Santa Rosa and Petaluma in order to use their Training Tower facilities. We believe in trying to standardize our operations as much as possible in order to share personnel between agencies without a need for more training. As well, we have been jointly purchasing items such as foam and other specialized products with other local agencies.

Again I can reassure you, the Russian River Fire Protection District will continue to do everything possible to comply with the requirements set forth within the 2002-2003 Grand Jury Final Report. Should you have any questions, or need more information, please give me a call at (707) 869-9089.

Dear Judge Tansil:

Recommendation R2 recommends that Fire District Boards enforce continual updating and correction of their maps at the new county-wide computer aided dispatch system.

A representative of the Schell-Vista Fire Protection District met with RedCom personnel prior to their start of operations, delivering a copy of our current map book for their use. This was the same map book in use by their predecessor agency.







The Timber Cove Fire Protection District has reviewed the section on Special Fire Districts in the 2002-2003 Grand Jury Report

We agree with recommendation R2 that Fire Districts should be diligent in assuring the accuracy of the district maps being used by the computer aided dispatch system used by REDCOM.

However, we would like to point out that our fire district, along with other fire districts, only learned within the past several months that the CAD system being used by REDCOM is a *GIS* system rather than the A*ddress*-driven system which was used for years by Central Dispatch.

(In our opinion, this may be the reason there are so many incorrect dispatches related to addresses.)

Now that we have finally been brought up to speed on the system requirements, we are in the process of sending REDCOM GPS locations for all boundaries of our district. Ultimately, we will have GPS locations for all addresses in the district, but that will take some time.



On behalf of the Board of Director's, I would like to take this opportunity to thank the Grand Jury and applaud them for recognizing our efforts to increase efficiency, reduce costs and benefit the citizens through development and participation in the Joint Powers Agreement between Valley of the Moon Fire District and the City of Sonoma. The key element of this successful arrangement is the support of our community; Fire District Board and City Council; administrative personnel; paid and volunteer firefighters. It has truly been and is a collaborative effort.

With regard to the Recommendations under R2, page 37, in that section which addresses "Special Fire Protection Districts", specifically "Fire district boards should enforce continual updating and correction of their maps", we respond with the following information.

This District's mapping program underwent a complete revision approximately one and one half years ago. This required extensive personnel hours to identify and record correct addresses throughout the District's 28.5 mile boundary. We utilized the mapping skills of Lynx Technologies of Capitola, California to produce our current maps. These maps were incorporated into run books and are carried on each emergency response apparatus. Copies were also provided to neighboring fire protection agencies and the County of Sonoma was provided a complete copy of our mapping data so it can be referenced in the GPS/CAD mapping system. The District has also purchased the necessary equipment and provided training to personnel to make as needed changes to the maps in house.




