Due to the ongoing state of emergency involving the spread of the COVID-19 virus in the County of Sonoma, and the resultant impact on the Sonoma County Sheriff's Office Detention Facilities, and for good cause showing, the Court hereby modifies its prior orders regarding the self-surrender date of each defendant listed in Exhibit A, which is attached hereto and incorporated herein, all of whom have previously been ordered to report to either the Sonoma County Main Adult Detention Facility (MADF) or the North County Detention Facility (NCDF), between May 30, 2020 through July 31, 2020.

PLEASE TAKE NOTICE: This order for modification of the surrender dates extends the turn-in date as follows and modifies the turn in location for all defendants to the Main Adult Detention Facility. All defendants listed in this Order must turn themselves into the Main Adult Detention Facility and not the North County Detention Facility.

This order has no other effect or impact on the sentence imposed to each defendant. Sentences will remain as previously imposed. Further, this order will only take effect upon the defendant timely presenting himself/herself for surrender to the Sonoma County Detention Facility pursuant to the already existing prior order. Failure of the defendant to present himself/herself at the Sonoma County Detention Facility as previously ordered will constitute a failure to surrender, and a warrant shall issue for their arrest in the normal course. Only by appearing as previously ordered will a defendant be granted the extension as provided herein.
