## DEPARTMENT GRAND JURY REPORT RESPONSE

Report Title: Sonoma County Emergency Evacuation Plans  
Are We Ready for the Next Major Evacuation?

### FINDINGS

The Sonoma County Civil Grand Jury determined that:

- F1. Sonoma County's Emergency Operations Plan, Hazard Mitigation Plan, and Department of Emergency Management are an excellent foundation for disaster preparation.
- F2. The County EOP is intended to be executed in an ad hoc manner without advance identification of specific evacuation routes or predesignated shelters.
- F3. Most of Sonoma County's major evacuation routes are incapable of accommodating predictable evacuation traffic in a timely manner.
- F4. Most roads critical to emergency evacuation in the unincorporated areas of Sonoma County have no remotely managed capability for controlling traffic flow, and existing traffic controls will not be operational during power failures.
- F5. The Sonoma County Sheriff's Office is primarily responsible for ensuring public safety during evacuations, but SCSO staffing may require temporary assignment of non-SCSO County employees for concurrent execution of household evacuation notices and evacuation route traffic management.
- F6. Organized community-based communications networks are a proven emergency resource yet remain only partly integrated into county and city emergency operations and communications infrastructures and require additional investment to provide county-wide coverage.

**F2-** The Sheriff's Office partially agrees with this finding. The Sheriff's Office agrees that advance identification of specific evacuation routes do not exist. Based on experience, evacuation routes need to be identified based on the known impacts of a specific incident, real-time information, and coordination with the numerous agencies responding to the incident. The Department of Emergency Management is responsible for the EOP; therefore, the Sheriff's Office neither agrees nor disagrees with findings related to the EOP.

**F4-** The Sheriff's Office neither agrees nor disagrees with this finding as the Sheriff's Office does not operate traffic control systems.

**F5-** The Sonoma County Sheriff's Office agrees that the Sheriff's Office is primarily responsible for ensuring public safety during evacuations. However, the Sheriff's Office does not agree that temporary assignment of non-SCSO County employees should be used for concurrent execution of household evacuation notices and evacuation route traffic management. Law enforcement personnel are used during evacuations because of the extensive training sworn officers receive, which includes disaster-response training. In addition, during evacuation operations sworn personnel use vehicles equipped with emergency lights, sirens (hi-lo), and radios that allow for emergency communication and coordination with other first responding agencies.

If the Sheriff's Office does not have sufficient staffing for evacuations existing protocols are already in place to address the issue. The Office utilizes local mutual aid, providing personnel from the following agencies:

If local mutual aid is insufficient, the Sonoma County Sheriff's Office utilizes out of county mutual aid through its designation under Region II (Alameda County) Law Enforcement Mutual Aid, coordinated by the Cal OES Law Enforcement Division. Cal OES expands the reach of mutual aid and access nationwide resources such as the National Guard (used during the Tubbs fire) if needed.

**F6** – The Sheriff's Office partially agrees. Organized community-based communications networks are a proven emergency resource. However, any effort to expand GMRS or ACS coverage county-wide must be strategically planned and coordinated countywide to ensure integration of these systems do not potentially compromise the integrity of existing public safety communications.

When implementing community-based communications networks, their design must avoid interference or noise that could affect public safety radio systems used by first responders and other essential agencies. Careful planning is critical, particularly in the areas of frequency allocation and coordination, training protocols, and system interoperability.

Fully integrating community-based systems requires additional investment, structured development, policy alignment, and coordination with existing operations. Only through such efforts can community-based systems become resilient, countywide support networks that operate seamlessly alongside established communications infrastructure.

**RECOMMENDATIONS**

The Sonoma County Civil Grand Jury recommends that:

R1. By December 5, 2026, the Board of Supervisors shall direct Sonoma Public Infrastructure to estimate and report the necessary cost and location of radio repeaters needed to fully implement GMRS repeaters serving the entire County.

R2. The Board of Supervisors shall direct the Department of Emergency Management to report on the resources required to accelerate Emergency Operations Plan Annex Goals SE2 and SE5 from 2030 to 2027 by February 2, 2026, and shall evaluate this

resource requirement for inclusion in the 2027 County budget.

- R3. By July 1, 2026, the Board of Supervisors shall fund Department of Emergency Management acquisition of evacuation management modeling and simulation software which will facilitate advance identification of zone-specific evacuation routes and evacuation messaging.
- R4. The Board of Supervisors shall direct the Department of Emergency Management to report on the resources required to identify and include within County Evacuation Maps the location of all predesignated county-operated evacuation shelters by March 2, 2026.
- R5. By July 1, 2026, the Board of Supervisors and the Sonoma County Sheriff shall review Sonoma County evacuation plans to determine whether trained and certified Sonoma County employees (using the authority granted by California Government Code Gov. Code §§3100–3102) should become a resource for emergency traffic control operations.



The Sonoma County Sheriff's Office does not believe it is reasonable to train and certify Sonoma County employees (using the authority granted by California Government Code Gov. Code §§3100–3102) to become a resource for emergency traffic control operations. Law enforcement personnel are used for traffic control for emergency road closures and in evacuation zones due to the extensive training that sworn officers receive, including disaster-response specific training.

Evacuated areas present significant public safety risks, including the potential for looting. Additionally, based on prior experience, emergency road closures and evacuation zones can become contentious when residents and/or motorists insist on accessing evacuated properties.

When the Sheriff's Office lacks sufficient staffing for emergency traffic control operations, existing protocols are in place to address the issue. These include local and regional mutual aid, as well as access to national assistance through the California Governor's Office of Emergency Services (Cal OES) Law Enforcement Division.
