1. PETITION OF TARASHEA SIRENIDIE 25CV05023

TENTATIVE RULING: The Petition is DENIED. Petitioner failed to provide a proof of service of publication at the first hearing on 10/08/25 as is required by Code of Civil Procedure §1277(a)(2). The Court provided an opportunity to cure this defect and set a second hearing for 11/12/25. As of this posting, Petitioner has still not provided a proof of service of publication for this new date.

2. PETITION OF RHEETA GOMEZ 25CV06086

TENTATIVE RULING: No Appearance is Required. The Court finds that Petitioner Rheeta V. Gomez has complied with all prerequisites outlined under California Code of Civil procedure ("C.C.P.") §1277 for a Petition for Change of Name. The Court has also reviewed Petitioner's Declaration of Diligent Search as to the biological father and GRANTS the Requests to Dispense with Notice as to biological father.
