How to Obtain Copies of Your Order

If a Petition for Name Change is approved, the Decree Changing Name (Order after Hearing) will be signed and processed within one to two business days following the hearing. The options to obtain a copy are:

-Pick up a copy or copies at the Civil Clerk's Office anytime during normal business hours. Certified copies may also be purchased at the Clerk's office.

-If you e-filed your documents and paid in advance for postage and a certified copy or copies of the Decree Changing Name, they will be mailed to you after the hearing.

-If you filed your documents in person and provided a self-addressed stamped envelope and either paid in advance or provided a check for a certified copy or copies of the Decree Changing, they will be mailed to you in that postage paid envelope after the hearing.
