- -If you e-filed your documents and paid in advance for postage and a certified copy or copies of the Decree Changing Name, they will be mailed to you after the hearing.
- -If you filed your documents in person and provided a self-addressed stamped envelope and either paid in advance or provided a check for a certified copy or copies of the Decree Changing, they will be mailed to you in that postage paid envelope after the hearing.
